ABSTRAK

Penelitian ini bertujuan untuk mencari tahu tentang hirarki kebutuhan manusia tercermin dari karakter utama dan juga jenis-jenis motivasi yang mempengaruhi karakter utama memenuhi kebutuhannya menggunakan teori Abraham Maslow. Jenis penelitian yang digunakan adalah penelitian deskriptif kualitatif dan analisis data menggunakan metode kualitatif dengan sumber data diambil dari film *Incredible 2*.

Dari penelitian ini ditemukan bahwa hanya empat jenis dari lima jenis hierarki kebutuhan manusia yaitu, kebutuhan fisiologis, kebutuhan keamanan, kebutuhan cinta dan kepemilikan, kebutuhan penghargaan, dan juga ada 2 jenis motivasi yang mempengaruhi karakter utama, yaitu motivasi intrinsik dan motivasi ekstrinsik. Dari penelitian ini diharapkan dapat digunakan oleh mahasiswa lain yang tertarik dengan hierarki kebutuhan manusia sebagai masalah psikologis.

ABSTRACT

The aimed of this study is to find out the Hierarchy of human needs reflected in the main character and then the kinds of motivation influence the main character fulfill her needs used Abraham Maslow theory. This study used descriptive qualitative method to describe the utterance and actions from the main character based on problem of the study. Source of data were taken from the *Incredible 2* film.

The result of this study found four types from five types hierarchy of human needs namely, physiologis needs, safety needs, love and belonging needs, and esteem needs. There are also two types of motivation that influence the main character, including intrinsic motivation and extrinsic motivation.

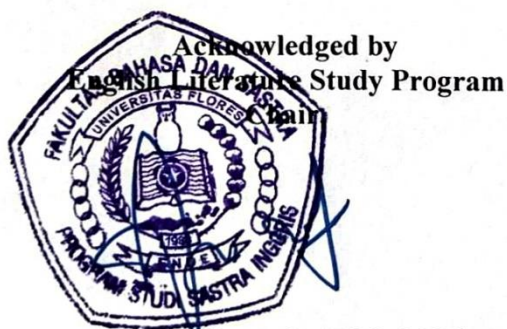

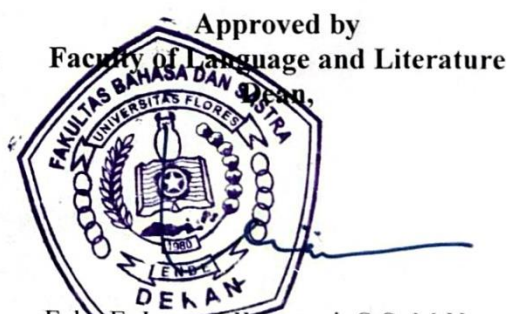
