This study aimed to explain how the symptoms of bipolar disorder experienced by Pat and the treatment are done by the character Pat in the novel *The Silver Linings Playbook*. This study is about individuals who experience bipolar. The approach used by the author in this study is a psychological approach and bipolar disorder theory to answer the research problem. This study uses a qualitative method design. This qualitative method takes into account that the data collected is analyzed using words and does not use numbers to answer research problems. The data was taken in the form of utterances, quotes, words, and sentences from *The Silver Linings Playbook*.

The results of the study show that there are four features of bipolar disorder that Pat experience, namely: heredity, abnormal brain structure and function, environmental factors, psychological factors, education and other treatment. Whilethere are three parts of treatment of bipolar disorder: medication, psychograph, education and other treatments.
