ABSTRAK

Tujuan dari penelitian ini adalah untuk mengetahui eksistensi tokoh sebagai “Liyan” dan strategi feminism eksistensialis tokoh dalam memaknai dirinya sendiri dalam filem *The Woman King*. Penelitian ini menggunakan metode deskriptif kualitatif. Dalam mendapatkan data, penulis melalui tiga langkah. Pertama, mengklasifikasikan data berdasarkan teori feminism eksistensialis yang direpresentasikan oleh karakter dalam film. Kedua, menganalisis data dengan menggunakan teori feminism eksistensialis dalam film untuk mengidentifikasi bagaimana eksistensi perempuan sebagai liyan dan strategi feminism eksistensialis yang ditunjukkan oleh karakter dalam film *The Woman King*. Ketiga, menarik kesimpulan berdasarkan analisis data.

Berdasarkan hasil analisis, penulis menemukan tiga penindasan terhadap perempuan sebagai “Liyan” yaitu perbedaan posisi perempuan dan laki-laki, kekerasan terhadap perempuan, dan pelecehan seksual. Penulis juga menemukan empat strategi feminism eksistensialis yang diwakili oleh karakter dalam film *The Woman King* yaitu perempuan dapat bekerja, perempuan dapat menjadi intelektual, perempuan dapat bekerja menuju transformasi sosialis dalam masyarakat dan perempuan dapat menolak untuk menginternalisasi bahwa perempuan berada di bawah laki-laki.

ABSTRACT

The aims of this study were to know the character existence as the “The Other” and find out the strategies of existentialist feminism of the character to interpret themselves in *The Woman King film*. This study used descriptive qualitative method. In getting the data have three steps. The first was classifying the data based on the theory existentialist feminism represented by the character in the film. The second was analyzing the data using the theory of existentialist feminism in the film and the last was drawing the conclusion based on the data analysis.

Based on the analysis, it shows there are three oppression of women exist as “the other” namely the different position of women and man, violence against the women, and sexual harassment and from this analysis also finds four strategies of existentialist feminism represented by the character in *The Woman King film*, namely women can go to work, women can become intellectuals, women can work toward socialist transformation in society and women can refuse to internalize that women are below men.
