ABSTRAK

Penelitian ini bertujuan untuk mengidentifikasi gejala gangguan depresi persisten yang dialami Millard sebagai tokoh utama dan untuk mendeskripsikan penyebab gangguan depresi persisten yang dialami Millard sebagai tokoh utama dalam film *I Can Only Imagine*. Metode penelitian yang digunakan dalam penelitian ini adalah metode deskriptif kualitatif. Penelitian ini menggunakan teori persistent depressive disorder oleh American Psychiatric Association, 2013 (dalam Ramalingam dkk, 2023) dan Krenke & Stremmler (2002) untuk menganalisis data, dan pendekatan psikologi juga digunakan dalam penelitian ini. Penulis menggunakan metode kepustakaan untuk menemukan teori dan data yang diperlukan untuk skripsi ini. Data primer terdiri dari film *I Can Only Imagine*. Data sekunder terdiri dari buku, artikel, jurnal, kamus, dan skripsi.

Hasil penelitian ini menjawab dua masalah. Pertama, gejala-gejala persistent depressive disorder yang dialami oleh Millard, sebagai tokoh utama dalam film. Ada tiga gejala persistent depressive disorder yang ditemukan dalam film ini yaitu *physical symptoms*, *psychological symptoms*, and *social symptoms*. Kedua, sebab dari persistent depressive disorder yang dialami oleh Millard sebagai tokoh utama yaitu *parental relationships* dan *personal and career pressures*.

ABSTRACT

This research aims to identify the symptoms of persistent depressive disorder experienced by Millard as the main character and to describe the causes of persistent depressive disorder experienced by Millard as the main character in the film *I Can Only Imagine*. The research method used in this research is a qualitative descriptive method. This research uses the theory of persistent depressive disorder by the American Psychiatric Association, 2013 (in Ramalingam et al., 2023) and Krenke & Stremmler (2002) to analyze the data, and a psychological approach is also used in this research. The author uses library methods to find the theory and data needed for this thesis. Primary data consists of the film *I Can Only Imagine*. Secondary data includes books, articles, journals, dictionaries, and theses.

The results of this research answer two problems. First, the symptoms of persistent depressive disorder experienced by Millard, the main character in the film. There are three symptoms of persistent depressive disorder found in this film, namely physical symptoms, psychological symptoms, and social symptoms. Second, the causes of Persistent Depressive Disorder experienced by Millard as the main character, namely parental relationships and personal and career pressures.






