ABSTRAK

Pengalaman traumatis merupakan peristiwa singkat yang memaksa pikiran kita untuk mengingat kembali pengalaman buruk dimasa lalu. Ini merupakan bagian dari pendekatan psikologis. Reaksi traumatis merupakan dampak traumatis yang dialami oleh tokoh utama dalam film *Midsommar*. Untuk mengetahui reaksinya, ada tiga konsep trauma yang diidentifikasi berdasarkan pemikiran Huang yaitu peristiwa, pengalaman, dan akibat. Di samping itu ada dua macam reaksi traumatis yang dieksplor berdasarkan penjabaran yang dikemukakan oleh Brier & Scot,etc. yakni reaksi langsung dan reaksi tertunda. Tujuan penelitian ini untuk mengetahui reaksi traumatis yang dialami Dani Ardor. Penelitian ini menggunakan deskriptif kualitatif dengan cara observasi.

Hasil analisis menunjukan bahwa Dani sebagai tokoh utama mengalami tiga konsep trauma yaitu peristiwa ketika ia harus kehilangan keluarganya, ia mengalami halusinasi setelah meminum jamur. Dampaknya, setelah menyaksikan kekasihnya berselingkuh dengan gadis lain, dan menghadiri acara Attestupa. Itu membawa pengalamannya beberapa hal buruk terjadi. Hasilnya ditemukan reaksi traumatis yang dialaminya berupa reaksi langsung dan reaksi tertunda yang meliputi reaksi emosional, fisik, kognitif, perilaku dan eksistensi. Hasil ini menunjukan bahwa pengalaman buruk yang terjadi secara langsung maupun tidak langsung dapat membuat seseorang bereaksi terhadap sesuatu yang mungkin berdampak pada kehidupannya.

A traumatic experience is a short event that forces our mind to rethink memories. It is a study of the psychological approach. The traumatic reaction is the effect of trauma experienced by the main character. To find out the reactions, Huang should identify the concept of trauma, namely event, experience, and effect. There are two kinds of traumatic reactions based on Brier and Scot's ideas: immediate and delayed. The aim of this study is to identify the traumatic reaction experienced by Dani Ardor. This study used qualitative descriptive by observation.

The analysis showed that Dani, as the main character, experienced the three concepts of trauma, which is an event; when she had to lose her family, she got hallucination after drinking fungus. Effects: After watching her boyfriend's affair with another girl, she attended the Attestupa ceremony. That caused her to experience some bad things. The result found that the traumatic reactions that she experienced were immediate reactions and delayed reactions, which include emotional, physical, cognitive, behavioral, and existential reactions. These results indicate that bad experiences that happened directly or indirectly could make a person react to something that might influence their life.


