ABSTRAK

Gangguan Obsesif Kompulsif (OCD) dalam karya sastra dapat dianalisis melalui pendekatan psikologi. Penelitian ini bertujuan untuk mengetahui penyebab dan dampak dari gangguan obsesif kompulsif yang dialami oleh tokoh Jasmine dalam film *Blue Jasmine*. Penelitian ini diharapkan dapat memberikan kontribusi yang lebih dalam bidang psikologi, khususnya tentang OCD.

Untuk mendukung analisis ini, penulis menggunakan beberapa teori yang berhubungan dengan permasalahan, yaitu teori sastra, karakter, pendekatan psikologi dan OCD. Penelitian ini menggunakan metode deskriptif kualitatif. Dalam mendapatkan data, penulis melalui tiga langkah. Pertama, mengklasifikasikan kutipan-kutipan yang berhubungan dengan permasalahan. Kedua, menganalisis gangguan obsesif kompulsif dalam film *Blue Jasmine*. Ketiga, penarikan kesimpulan setelah semua data dianalisis, dideskripsikan dan dijelaskan.




