ABSTRAK

Tujuan dari penelitian ini adalah untuk mengetahui tipe dan penyebab mekanisme pertahanan diri dari tokoh utama dalam film *Enola Holmes* menggunakan pendekatan psikoanalisis. Penelitian ini menggunakan metode deskriptif kualitatif. Dalam mendapatkan data, penulis melalui tiga langkah. Pertama, mengklasifikasikan data berdasarkan teori mekanisme pertahanan diri yang berkaitan dengan karakter utama dalam film. Kedua, menganalisis data berdasarkan teori mekanisme pertahanan diri untuk mengetahui jenis-jenis mekanisme pertahanan diri, dan penyebab mekanisme pertahanan diri yang terdapat pada karakter utama dalam film. Ketiga adalah membuat kesimpulan berdasarkan hasil penelitian.

Berdasarkan hasil analisis, penulis menemukan lima tipe mekanisme pertahanan diri dari pemeran utama, *Enola* dalam Film *Enola Holmes* yaitu *denial, rationalization, displacement, regression, dan sublimition.* Penulis juga menemukan *anxiety* sebagai penyebab dari mekanisme pertahanan diri karakter utama, Enola dalam film *Enola Holmes* dengan dua tipe *anxiety* yang menonjol yaitu, *realistic anxiety* dan *neurotic anxiety*.

ABSTRACT

The aims of this study were to determine the types of defense mechanism and the causes of defense mechanism of the main character in the film *Enola Holmes* using Psychoanalysis approach. This research used qualitative decriptive method. In obtaining data, the writer went through three steps. First, classifying the data based on the theory of defense mechanism related to the main character in the film. Second, analyzing the data using the theory of the defense mechanism to find out the types of defense mechanism, and the causes of the defense mechanism found in character as seen through the main character in the film, anda third, made a conclusion based on the result.

Based on the analysis, the writer finds five types of defense mechanism of the main character, Enola in *Enola Holmes* Film, namely denial, rationalization, displacement, regression, and sublimation. The writer also finds anxiety as the cause of defense mechanism of the main character, Enola in film *Enola Holmes* with two types of anxiety, namely realistic anxiety and neurotic anxiety.
